NOTIFICATION

WHEREAS, in exercise of the powers conferred by sub-section (3) of Section 1 of the West Bengal Town and Country (Planning & Development) Act, 1979 (West Bengal Act XIII of 1979), the provisions of the said Act were brought into force in the area described in the Schedule appended to this Department's Notification No. 3445-T&CP/1C-6/89 dated 28th November, 1990. Thereafter, the said area comprising 16 mouzas, was declared to be the Planning Area vide Notification No. 3446-T&CP/1C-6/89 dated 28th November, 1990, and the Digha Planning Authority was constituted for the said Planning Area vide Notification No. 3447-T&CP/1C-6/89 dated 28th November, 1990.

AND, WHEREAS, the Planning Area was subsequently extended through Notification No. 4350-T&CP/1C-6/89 dated 28th November, 1991 by inclusion of 26 additional mouzas. Thereafter, the Digha Development Authority was constituted vide Notification No. 857-T&CP/1C-6/87 dated 4th March, 1993, which was subsequently reconstituted as the Digha Sankarpur Development Authority (DSDA) vide Notification No. 5319-TPCP/C-2/1P-5/2003 dated 24th September, 2003. The planning area under DSDA was further extended in 2011 and 2012 vide nos. 2551-T&CP/C-2/1P-5/2003 dated 22.12.2021 and 901-T&CP/C-2/1P-5/2003 dated 30.04.2012. At present, the planning area under DSDA comprises 51 mouzas in the district of Purba Medinipur.

AND, WHEREAS, with a view to facilitating integrated and planned development of the adjoining coastal areas, harness their tourism potential, promote orderly growth, generate employment opportunities and contribute to the overall socio-economic development of the region, the State Government has decided to extend the jurisdiction of the Digha Sankarpur Development Authority (DSDA) by bringing within the ambit of the West Bengal Town and Country (Planning & Development) Act, 1979 (West Bengal Act XIII of 1979), an additional 202 mouzas situated in Contai-I and Contai-II Blocks, as specified in the following Schedule, and thereafter to amalgamate the Planning Area so declared with the existing Planning Area of the Digha Sankarpur Development Authority (DSDA).

NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of Section 1 of the West Bengal Town and Country (Planning & Development) Act, 1979 (West Bengal Act XIII of 1979), the Governor is hereby pleased to appoint the date of publication of this Notification in the Official Gazette as the date on which the provisions of the said Act shall come into force in the area described in the above Schedule.

AND, FURTHER, in exercise of the powers conferred by sub-section (1) read with sub-section (2) of Section 9 of the said Act, the Governor is hereby pleased to declare the area described in the above Schedule to be a "Planning Area" for the purposes of the said Act.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (3) of Section 9 of the West Bengal Town and Country (Planning & Development) Act, 1979 (West Bengal Act XIII of 1979), the Governor is hereby pleased to amalgamate the "Planning Area" described in the above Schedule, with the existing Planning Area of Digha Sankarpur Development Authority (DSDA), for the purpose of the West Bengal Town and Country (Planning & Development) Act, 1979 (West Bengal Act XIII of 1979), with effect from the date of publication of this Notification in the Official Gazette.
